**Purpose of the event (short description):** Recent developments in EU law have brought about fundamental changes. In this context, the legislative focus has increasingly shifted towards a horizontal development of the law, due to the green and digital transition and the extension of fundamental rights protection at EU level. The objectives and instruments used so far should be examined in the context of an event that allows for the widest possible involvement of experts and the public. This includes both representatives of the sectors and the public interested in the horizontal development of EU law. The event will be organised during the Hungarian Presidency of the Council in 2024, which will also allow for the discussion of specific points of the Presidency programme.
